NOTICE

For students admitted in Acad. Year 2016-17 and 2017-18

Students under different categories who have taken admission through Maharashtra State's Centralized Admission Process (CAP Round) in Academic Year 2016-17 and 2017-18 are eligible for different types of scholarship scheme as follows :-

Sl.	Name of Scheme	Eligibility
1.	Rajashri Chhatrapati Shahu Maharaj Shikshan Shulk Shishvruti Yojana	Admission done through CAP Round.
2.	Government of India Post-Matric Scholarship & Post-Matric Tuition Fee and Examination Fee for Reserved Category (SC/NT/VJ/DT/SBC/OBC)	
3.	Post Matric Government of India Scholarship and Tuition Fee (Freeship) for ST category student.	
4.	Dr. Punjabrao Deshmukh Vastigurh Nirvah Bhatta for student of Smal Landholder of Farmer and Registered Labour.	
5.	Government of Maharashtra Minority Scheme (Admission done through CAP round, Management Quota or against vacancy on institute level)	Muslim, Buddhist, Sikh, Parsi, Christian and Jew

All those students who wish to apply for above scheme to avail fee reimbursement are required to register their name and fill on-line form on Government of Maharashtra's website <https://mahadbt.gov.in>

Government has not yet declared last date for the filling of on line form. But all are required to fill the form at the earliest and check twice/thrice before submitting the same.

Special note for Students & Parents:

1. Student is solely responsible to fill scholarship form before last date. If student has not filled the form then he has to pay full fees as decided by Shikshan Shulk Samiti and he will be responsible for the same.
2. Students have to open Saving Bank Account in any Nationalised Bank ('Zero' balance account or Joint a/c with parent is not applicable.)
3. Bank Account should be linked to Aadhar card and Aadhar card to be linked with mobile no. from Aadhar Centre. If age of the Student is less than 18 years then his mobile no. will not be linked. In this case parent's mobile no. can be linked with Aadhar and that linked mobile should be with student while registration of form as One Time Password (OTP) no. has to be put immediately in the form to complete the registration process.
4. Students attendance should be above 75% which is mandatory to avail benefit of the above scheme.


Documents required:-

These documents have to be uploaded one time only hence it should be in good quality. (Photo taken from mobile or camera and kept in PDF format is not applicable).

List of documents (Student should submit documents as per category wise and course wise.)

1. CAP Admission Allotment Letter.
2. Student's Aadhar Card
3. Ration Card
4. SSC Marksheet
5. HSC Marksheet
6. Leaving Certificate/Transfer Certificate (As applicable)
7. All lower semester's marksheet of Diploma.
8. Domicile Certificate (Maharashtra domicile certificate is compulsory, No other option for domicile.)
9. Income Certificate from Tehsildar only. (No other documents will be considered i.e Form 16, or income certificate issued by Employer, Corporator etc.)
 - a) Students admitted in Acad. Year 2016-17 - Income Certificate of F.Y 2016-17.
 - b) Students admitted in Acad. Year 2017-18 - Income Certificate is of F.Y. 2016-17
 - c) In case of ST Category, every year new income certificate has to be submitted

11. Caste Validity Certificate (For ST category student Caste Validity is compulsory, for other category caste certificate is not compulsory but student should apply on-line)

13. Gap Certificate (Gap Certificate should be registered from Tehsildar office)
